## **Public Notification**

The Ministry of Agriculture & Forests (MoAF) would like to notify the general public that the African Swine Fever (ASF) outbreak has been confirmed in a backyard pig farm in Gayzor under Dewathang geog, Samdrup Jongkhar Dzongkhag.

ASF is a highly contagious viral disease of domestic and wild pigs with a mortality rate of up to 100%. The disease is spread through contacts between pigs (domestic or wild), contaminated pig products, feeding pigs with kitchen wastes contaminated with pork products, through movement of contaminated personnel and farm equipment (fomites). As of now, there is no vaccine and effective treatment available for ASF. Although ASF does not affect human health, it can cause catastrophic socio-economic consequences for the pig farming sector. Despite repeated notifications issued by the Ministry, we have encountered individuals illegally importing live pigs, pork and pork products. A farmer from Pemathang geog under Samdrup Jongkhar Dzongkhag was recently caught and penalized for illegally importing live pigs from Assam.

The Ministry would like to reiterate the reinforcement of containment measures including the ban on movement and sale of pig and pig products that are currently being put in place by the local authorities.

Further, the pig farmers within the country are urged to heighten biosecurity in their farms; ensure kitchen wastes are properly cooked before feeding to the pigs; prevent domestic pigs from coming into contact with wild pigs; and report any suspicious deaths in domestic or wild pigs to the nearest livestock centres or BAFRA office. You can also report un-usual illness and mortality in pigs to toll-free numbers 1244 (DoL) or 1555 (BAFRA).

Livestock and BAFRA officials shall ensure that the above measures are strictly adhered to, by the relevant stakeholders. Any person found not adhering to this notification shall be firmly dealt in accordance with the Livestock Act of Bhutan 2001.
